RESTRICTIVE COVENANTS FOR LAKEVIEW ESTATES, GRAHAM TOWNSHIP, ALAMANCE COUNTY, A PLAT OF WHICH IS DULY RECORDED IN THE OFFICE OF THE REGISTER OF DEEDS FOR ALAMANCE COUNTY, NORTH CAROLINA IN PLAT BOOK AT PAGE 53.

The Restrictions imposed hereby are as follows:

- 1. No business of any kind shall be permitted on this property. No buildings shall be erected, altered, placed or permitted to remain on any lot other than one detached single family dwelling not to exceed 2 ½ stories in height and a private garage for not more than two cars.
- 2. No dwelling shall be permitted on any lot where the ground floor area of the main structure, exclusive of one story open porches and garages, that shall be less than 1200 square feet for a one story dwelling, nor less than 800 square feet for a dwelling of more than one story.
- 3. No imitation siding may be used on any dwelling and no cement blocks can be left showing from outside appearance.
- 4. No residence shall be built near the front property line than 40 feet nor nearer the side line than 10 feet.
- 5. No residence shall be built upon any lot of less than 20,000 square feet.
- 6. No noxious or offensive activities shall be carried on upon any lot nor shall anything be done thereon which may be or may become an annoyance or nuisence to the neighborhood.
- 7. No structure of a temporary character, trailers, basement, tent, shell homes, shack, garage, barn, or other out building shall be used on any lot at any time as a residence either temporarily or permanently.
- 8. No sign of any kind shall be displayed to the public view on any lot except one professional sign of not more than one square foot, one sign of not more than five square feet advertising the property for sale or rent, or signs used by a builder to advertise the property during the construction and sale period.
- 9. No animals, livestock, or poultry of any kind shall be raised, bred, or kept on any lot, except that dogs, cats or other household pets may be kept provided that they are not kept, bred, or maintained for any commercial purpose.

10. No Lot shall be used or maintained as a dumping ground for rubbish. Trash, garbage, or other waste shall not be kept except in sanitary containers. All incinerators or other equipment for the storage or disposal of such material shall be kept in a clean and sanitary condition.

- 11. All sewage disposal shall be made through the use of approved septic tanks.
- 12. These covenants are to run with the land and shall be binding on all parties and all persons claiming under them for a period of thirty years from the date these covenants are recorded, after which time said covenants shall be automatically extended for successive periods of 10 years unless an instrument signed by a majority of the then owners of the lots has been recorded, agreeing to change said covenants in whole or in part.
- 13. Enforcement shall be by proceedings at law or in equity against any person or persons violating or attempting to violate any covenants either to restrain violation or to recover damages.
- 14. Invalidation of any one of these covenants by judgment or court order shall in no wise affect any of the other provisions which shall remain in full force and effect.
